Dear Families,

We will start Minekill on Monday, July 6th through Thursday the 31<sup>st</sup>. We are only going four days a week, Monday through Thursday. **There will be no Minekill on Fridays.** The pickups are at Agway and the Trailer park. The bus will pick up at 10:00 and be back around 3:20. Children that leave before 3:00 will have to be picked up by a parent/guardian or have a note to leave with someone else. If we have bad weather while at Minekill, and have to leave early please have arrangements made to meet the bus at the assigned pickup. We will notify parents through the **app** or a **phone call home**.

Your child will need to bring a bag lunch. There is a snack shack if you would like to send money. We eat lunch as a group. We put all our things together in one central location. We do not recommend the use of the lockers. We cannot be responsible for any lost or stolen property at the pool.

### **Behavior issues:**

1. Your child is expected to participate in swimming

lessons, refusal to do so will result in them being told that they are no longer able to attend.

2. Foul language, fighting and bad behavior and refusal to follow pool and counselor rules will not be tolerated. Your child will receive a warning for the first offense, a phone call home on the second offense and will be removed from the program on the third offense.

### **Responsibilities of your child:**

Each child needs to have a towel, swimsuit and sunscreen clearly labeled with their name. Please apply sunscreen before your child leaves each day. We will have them reapply sunscreen after we eat lunch. Please encourage your child to reapply throughout the day. If your child is prone to sunburn, **please** purchase a swim shirt for them to wear in the pool. If your child has swim shoes, they may want to bring them because the bottom of the pool is very rough.

Children will not be permitted to stay after lessons or ride home with someone else, unless they have written parental permission. **If you are picking up your child you must sign them out. (see counselor)**

**It is not the responsibility of the counselors to keep track goggles and money. If you send money in that you would like us to hold on to for your child, please put in a clearly marked zip lock bag. PLEASE NO TOYS!**

You may fill out the form and send it back to school with your child by **Wednesday June 3rd. Please have the paperwork back on time. We need to have a head count for buses.** (Please have them bring it to Mrs. Haight)

Your child must meet the following requirements to be able to participate in the program.

1. Child must have a parent or grandparent who is a resident of Prattsville.
2. Children must have completed Kindergarten.
3. Children registered must start by the beginning of the second week (unless otherwise approved)
